Participant Release and Waiver of Liability Form

This Release and Waiver of Liability (the "Release") executed on by the undersigned participant ("Participant") releases Unity Through Creativity Foundation, ("UTC") a nonprofit corporation, and each of its directors, offices, employees, and agents from any and all liability. "Participant" in the context of this document refers to vendors and/or presenters at UTC events.

The Participant understands that the scope of the Participant's relationship with UTC is limited to being a vendor or presenter at one or more UTC-sponsored events and that the Participant is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Participant's participation in said event(s).

1. **Waiver and Release:** I, the Participant, release and forever discharge and hold harmless UTC and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise in the course of my participation in UTC-sponsored event(s). I understand and acknowledge that this Release discharges UTC from any liability or claim that I may have against UTC with respect to bodily injury, personal injury, illness, death or property damage that may result from my participation as a vendor.
2. **Insurance:** Further I understand that UTC does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of UTC beyond what may be offered freely by UTC in the event of such injury or medical expenses incurred by me.
3. **Medical Treatment:** I hereby Release and forever discharge UTC from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my participation as a vendor.
4. **Assumption of Risk:** I hereby expressly assume the risk of injury or harm from these activities and release UTC from all liability for injury, illness, and death or property damage resulting from my participation as a vendor.
5. **Photographic Release:** I grant and convey to UTC all right, title, and interests in any and all photographs, images, video or audio recordings of me or my likeness or voice made by UTC in connection with my participation as a vendor.
6. **Other:** I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the state in which each event is being held. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.

By signing below, I express my understanding and intent to enter into this Release and Waiver of Liability willingly and voluntarily for myself and on behalf of any members of my vendor group. A guardian's signature is required if the Participant is of age under 18.
